5TH OCT, 2015, FROM 3 TO 6 PM**

Bank retirees are aware that in the 10th Bipartite settlement/ joint note finalized on 25th May, 2015, for Bank workmen and officers the issues relating to retirees were not settled. They were not even addressed properly. On the contrary, a record note, containing highly prejudicial contents was signed between the IBA and the UFBU. In this back ground, the ALL INDIA BANK RETIREES' FEDERATION, of which we are an affiliate, in its Indore CC meeting, held on 9th and 10th July, 2015, has decided to make all out efforts to get retirees' issues resolved.

Main issues concerning the bank retirees which are pending for a very long time are:

1. 100% D.A. to pre-Nov, 2002 retirees
2. Improvement in Family pension
3. Updation of Pension
4. Pension to Resignees, compulsorily retired persons, etc

In pursuance of these demands, members of AIBRF have already conducted several organizational programmes, such as Demonstrations, Dharnas etc in various centres all over the country.

In Bangalore, on 31st, May, 2015, a massive Demonstration by AIBRF was held before Vijaya College Premises, on the occasion of the All India Conference of Syndicate Bank Retirees' Association, in which the General Secretary of AIBRF, Sri. S C Jain also participated.

As these issues still remain unsettled and immediate resolution is the need of the hour, the Karnataka State Committee of AIBRF, in its meeting held on 9th Sept, 2015, has decided to hold a massive Dharna by bank retirees, in front of Town Hall, J C Road, Bangalore, on Monday, the 5th October, 2015, between 3 pm and 6 pm.

On this occasion, we call upon all our members and retirees to show our solidarity and determination to unitedly fight for our legitimate rights, which, the Govt, the IBA and other vested interests are attempting to delay and deny.

With this in view, we hereby call upon all our members and retirees to participate in the Dharna and display our unity, determination and resolve to get our issues resolved.

Friends, today's retirees were yesterday's employees. They have brought the banks to this size and position by their dedication and hard work. They have built these institutions brick by brick by giving their exemplary services. They deserve respect, care, concern and consideration in their advanced age. It is time, all bank retirees stand united and face the challenges thrown at them. We have created history in the past. Let us create history once again.
